- Pose Safety Risks: Obstructions may block emergency exits or hinder access in case of an emergency.
- Violate Regulations: Housing regulations require communal spaces to remain unobstructed.
- Affect Community Cleanliness: Items left in shared spaces can make the area look cluttered and harder to maintain.



Tips to manage your rent arrears

- 1. Contact landlord immediately. Explain situation & request a meeting.
 Katherine Forsyth at Coop Homes has been very helpful in supporting people with their rent arrears.
- 2. Create a budget. Prioritise rent. Identify areas to cut costs.
- 3.Explore assistance: Benefits check. Seek local charities.
- 4.Seek professional advice: Contact a debt advisor.
- 5.Negotiate a repayment plan. Work with the landlord.

As many tenants will be aware the stock condition survey is well underway. 30% of properties have now been surveyed and Brasier Freeth predict they will be completed by the end of March. The full stock condition survey report will help to identify and address immediate maintenance needs, ensure compliance and produce a schedule for planned home improvements. Thereby increasing tenant satisfaction, enhancing property value and creating a more sustainable and financially sound future.



Policy and Regulation Updates

Good news for social housing tenants! New rules came into effect on April 1st, 2024, thanks to the Social Housing Regulation Act. These rules apply to all landlords, including councils and housing associations.

Key Changes:

- Safety First: Landlords must ensure your home is safe and secure
- Improved Accountability: Landlords will be held accountable for their actions and must treat you with respect.
- Data-Driven Improvements: Landlords will use data to better understand your needs and improve their services, including repairs.
- Better Service: Landlords must listen to your concerns, respond quickly to complaints, and treat you fairly. The complaint policy can be viewed here: https://www.coophomes.coop/about-us/compliments-and-complaints/

These changes aim to improve the living conditions and experiences of social housing tenants across the country.
